Terms

1. All dealer stock orders are to be pre-paid by credit card, Cashier's Check or Money Order.
2. All custom orders (frames, motors, custom fenders, etc.) must be paid in full before order is processed.
3. All foreign orders, must be paid in US dollars

4. In order to maintain a status as a dealer for Northside Choppers, you must purchase a minimum of \$2,500 in parts annually. If this is not met, the dealer will be removed out of our system, and must simply re-apply by completing another application for review.

Motorcycle Orders

1. All dealers selling Northside Choppers motorcycles are required to have a minimum of 3 complete build orders annually. If this is not met, the dealer will be removed out of or system, and must simply re-apply by completing another application for review.

Warranty

1. All parts are guaranteed against defects in the material, or workmanship by Northside Choppers.
2. All claims must be made within 30 days.
3. Northside Choppers will not be responsible for incidental or consequential damage including paint, powder coating, chroming, or wiring.

Shipping

1. All freight charges are to be paid by the customer
2. All orders are shipped via UPS, Federal Express, or Roadway unless they exceed the weight limit and require another form of transportation.

Claims

1. Delivery of orders in good condition is the responsibility of the carrier. If order arrives damaged and it's the apparent it is damaged by the carrier, a claim with that carrier should be made within 10 days of the date that you received your order.

Returns

1. All orders returned to Northside Choppers, must be authorized first by Northside Choppers. This will help move the process along.
2. Please enclose a copy of your original invoice when returning your order.
3. All orders returned due to a shipping, invoicing or manufacturing error, will be dealt with immediately upon arrival.
4. Northside Choppers will not accept return orders due to a change of mind.
5. Any orders refused will be charged a 25% restocking fee.
6. All return orders must be done within 15 days of the invoice date.
7. Northside Choppers will not accept returns on custom orders, or modified parts.
